July 30, 2015 Board Meeting Minutes. The motion passed unanimously.

Dr. Gladys Cruz, District Superintendent, Questar III BOCES, introduced Ms. Christine Carpenter, a veteran of the Capital Region BOCES Communications Service, who will serve as an interim Communications Specialist at TVHS while a successor for Lucian McCarty is recruited. She also presented Mr. Matthew Sloane, Deputy Superintendent of Questar III, who will work with Dr. Lynne Wells, Assistant District Superintendent for Curriculum and Instruction, Capital Region BOCES, as a liaison with TVHS. It was moved by Mrs. Lenhardt and seconded by Mr. Brooks to enter into **EXECUTIVE** Executive Session at 6:20 p.m. The motion passed unanimously. SESSION It was moved by Mrs. Lenhardt and seconded by Mr. Brooks to reconvene the Regular Session at 6:45 p.m. The motion passed unanimously. Mr. Kutzscher and Mrs. Orvis continued the conversation started before the Executive Session by asking Mr. Sloane how many of the TVHS students have IEP's. He responded that 22% of the students have IEP's. Dr. Bergeron indicated his concern that some kinds of IEP's are not able to be delivered in the TVHS environment. Mr. Sloane reported that an academic subcommittee is developing a screening document that has guidelines including a student profile and course descriptions to assist students and parents considering TVHS. He said he would be meeting with home district guidance counselors to ensure students' success at TVHS. Mr. Sloane indicated that after students tour TVHS, they will meet with their home district guidance counselors to reinforce if TVHS will be a good fit. A question was raised about the part-time appointment of the Teaching Assistant **PERSONNEL** for physical education. Mr. Niedermeier responded that due to the classes being **CONSIDERATIONS** held off site, the teaching assistant would ensure the adult/student ratio for supervision. The motion passed unanimously.

Mr. James Niedermeier, Principal and Chief Academic Officer, began his report P by summarizing the events during the first weeks of school which included offering TVHS students opportunities for off-site exploration such as a tour of the CNSE labs and the back to school expo at the convention center. He shared a list of partners working on projects with TVHS students. He also summarized priority areas to be addressed during the 2015-16 school year and the TVHS graduation requirements. President Puccio commented on students in home districts having the opportunity to take higher level courses starting in the 8<sup>th</sup> grade. Dr. Gladys Cruz, District Superintendent, Questar III BOCES, noted the Excelsior Program provides online college credits.

Mr. James Church, Director of Strategic Planning Initiatives, Questar III BOCES, began the Advancement Activity Report by noting he had met with most Foundation Board members to discuss their visions. He highlighted the raising of funds to cover the costs of college credits. He discussed replication efforts and being proactive in talking with higher education institutions who train teachers to encourage the focus on project based learning. Mr. Church reported that the Capital Campaign had raised \$170,000 so far. He indicated that John Cavalier would be moving out of the area, and his leaving would bring the vacancies on the Foundation Board to two. He noted that TVHS expected a

visit from State Senator George Amedore and that Assemblyman John McDonald would be coming in the future. Mr. Phelan suggested these visits could be augmented with trips to the Capitol on BOCES lobbying day and other days designated for meetings with legislators. It was agreed that lifting the BOCES cap is on ongoing issue. Discussion continued about the importance of establishing connections with those of influence on the CNSE campus. Mr. Church stated that an application is being prepared to submit to the University at Albany for TVHS physical education activities. Mr. Kutzscher inquired about the possibility of replication with GlobalFoundries. President Puccio thanked Mr. Church and noted his work is extremely valuable to TVHS. Mrs. Lenhardt asked if anyone from the Division of the Budget had come to TVHS. Mr. Church replied that last spring a group of 6 or 7 had visited and were impressed.

Ms. Denise Zieske, Business Partnership Coordinator, announced that Mr. John Yaglieski would be meeting with the Business Alliance Co-chairs. President Puccio noted the recent directory produced by the Business Alliance and conveyed appreciation on behalf of the Board. Discussion followed about the next Design Expo. Board members concurred that the expectation was for promotion of better projects for the May Expo. Ms. Zieske reminded the Board that TVHS graduation will be June 23, 2016.

Dr. Cruz reiterated that her TVHS role would transition to Mr. Sloane as he begins working with Dr. Wells as a liaison for TVHS. She also noted that Mr. Sloane would be recruiting a replacement for Mr. Chris Casey who is leaving Questar III BOCES. Mr. Casey had a major role in the analysis and reporting of TVHS student performance data. Dr. Cruz emphasized that gaining access to and working on the data continues to be challenging.

It was noted that a photo of the Board will be taken at the next Board meeting **BOARD** on November 18. Mr. Brooks inquired about the size of the incoming freshman class and if the other class sizes are stable. Mr. Niedermeier responded that the class sizes are 42, 35, 28 and 26, respectively.

The following items are follow-up items for the next meeting.
