DEI @ TVHS Last year a 5 session roundtable informing them of what it's like to work at Google, Microsoft, etc. and how to get there if that's your goal. A series of conversations will be had through April. Aimed at black and brown students.
Exploring and Sharing our Stories - invitation coming for May 2023. Exploring who we are, what our own story is and how it impacts the world.
Lobby Day - Thank you to Julie Marlet. Brought 6 students and they got to be on the floor and go to the million dollar staircase advocating for the TVHS program and shining in articulation and offering their perspective of TVHS.
Students are feverishly finishing their iTerm plans.
Innovative Solutions - November was the kick-off. Working with business partners to help solve problems in their business.
Dr. Cruz said it was great to see the collaboration with UAlbany. Conversations regarding the partnership have begun and we expect it to be better going forward. Excited to see the TVHS student be integrated into Regional PRHYLI (5 students of 30) spoke regarding critical thinking and applying it to debating bills.
Ms. Murphy reported that she continues to work with the superintendents to offer access to their students to TVHS and she will continue those conversations in an effort to be inclusive of all districts and their students who wish to attend TVHS.
